The Empire District Electric Company, The Empire District Gas Company, Liberty Utilities (Midstates Natural Gas) Corp., and Liberty Utilities (Missouri Water) LLC, all subsidiaries of Algonquin Power & Utilities Corp., have filed an application with the Missouri Public Service Commission seeking approval of their Cost Allocation Manual (CAM). The parties have continued to negotiate the terms of such CAM and on December 15, Staff filed a status report.

Staff indicates the parties have agreed that further negotiations will be helpful and ask that Staff be directed to file another status report by March 30, 2018.

The Commission accepts the recommendation of the parties and will direct Staff to file a status report as proposed.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a status report regarding the state of negotiations by March 30, 2018.
