ORDER SUSPENDING TIMELINE FOR RESRAM PRUDENCE REVIEW AND DIRECTING NOTICE

Issue Date: March 14, 2016 Effective Date: March 14, 2016

In File No. EO-2014-0151¹ ("earlier action"), the Commission approved a renewable energy standard rate adjustment mechanism ("RESRAM") for KCP&L Greater Missouri Operations Company's ("GMO") by tariff.² That tariff provides, and the Commission's regulations allow,³ a prudence review of GMO's RESRAM in any general rate action. This general rate action began when GMO filed tariffs and an application for a general rate increase. Accordingly, Staff filed the pending motion ("the motion").⁴

The motion gives notice that Staff is starting its prudence review of GMO's RESRAM as the Commission's regulations require.⁵ The motion asks the Commission to serve the motion on all parties in the earlier action so that such parties have notice of the prudence review and may seek intervention.⁶ The Commission will grant that request.

The motion also gives notice that Staff intends to offer the results of the prudence review in this action.⁷ For that reason, the motion asks the Commission to suspend the timeline that the regulations prescribe for a stand-alone RESRAM prudence review.⁸ The Commission's regulations allow suspension of the timeline to conduct discovery or for other good cause.⁹ Good cause means a good faith request for reasonable relief.¹⁰ The Commission will grant that request.

THE COMMISSION ORDERS THAT:

- 1. The motion described in the body of this order ("motion") is granted and the timeline described in the body of this order is suspended.
- 2. The Commission's Data Center shall serve a copy of the motion on all parties to the action in File No. EO-2014-0151.
 - 3. This order shall be effective when issued.
