Comes now the Missouri Industrial Energy Consumers ("MIEC") and, pursuant to 4 C.S.R. 240-2.075 and this Commission's July 12, 2016 *Notice of hearing; Order setting conference date, Directing notice of action, Establishing Intervention date, and Directing filings*, files its application to intervene. For its application, the MIEC states as follows:

1. The MIEC is a Missouri nonprofit corporation that represents the interests of industrial customers in matters involving utility issues. Those interests include the interests of large industrial customers of Kansas City Power & Light Company.
2. As a representative of large industrial customers, the MIEC's interest is different than that of the general public and may be adversely affected by a final order arising from this case.
3. The MIEC will likely oppose some of the relief sought by Kansas City Power & Light Company in this case, and reserves the right to take positions on specific issues as this case proceeds.
4. The MIEC's intervention will serve the public interest by assisting the Commission's record for decision in this case.
