

**FIRST AMENDED APPLICATION OF
CABLE & WIRELESS GLOBAL MARKETS, INC.
TO CANCEL ITS CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW Cable & Wireless Global Markets, Inc. ("CWGM") by and through its attorney and, pursuant to Section 392.410.5, RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariffs. In support of its Application, CWGM states as follows:

1. CWGM is a certificated interexchange carrier in Missouri with its principal place of business located at 8219 Leesburg Pike, Vienna, Virginia 22182. CWGM, a Delaware corporation, was authorized on August 2, 1999, in Case No. TA-99-586, to offer, render, furnish or supply interexchange telecommunication services as a reseller to the public within the state of Missouri. CWGM's Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.

2. Due to a change in business plans, CWGM requests the Commission to cancel its Certificate of Service Authority and Tariffs since CWGM has no existing customers on these services and has generated no revenue for over a year within this market. Accordingly, CWGM does not have to notify anyone regarding discontinuance of service in Missouri.


