ORDER SETTING LOCAL PUBLIC HEARINGS AND DIRECTING NOTICE

Issue Date: November 3, 2006 Effective Date: November 3, 2006

On July 10, 2006, Union Electric Company d/b/a AmerenUE submitted to the Missouri Public Service Commission certain proposed tariff sheets to implement general rate increases for its retail electric service and its natural gas service to customers in its Missouri service area. The Commission opened case number ER-2007-0002 to address AmerenUE's electric rate increase request and case number GR-2007-0003 to address AmerenUE's natural gas rate increase request.¹

On August 25, 2006, the Office of the Public Counsel filed its Recommendations for Notice and Public Hearings in the AmerenUE Rate Cases. Public Counsel recommended

that the Commission conduct twelve local public hearings in specified locations in mid-January, as the Commission's schedule permits. Public Counsel also proposed language to be sent to AmerenUE's customers as notice of the AmerenUE Rate Cases.

On August 29, 2006, AmerenUE filed its response to Public Counsel's recommendations. In its response, AmerenUE generally objected to the number of public hearings recommended by Public Counsel by asking the Commission to "consider whether indeed 12 local public hearings are needed." AmerenUE also requested that a paragraph be added to Public Counsel's proposed customer notice to also provide notice of its request for a fuel adjustment clause (FAC). In response, Public Counsel asked the Commission to deny AmerenUE's request to amend the proposed notice and order AmerenUE to specifically state whether it opposes Public Counsel's recommendations for public hearings, and if so, to file its own recommendations. No other party filed any objections to or comments regarding either Public Counsel's recommendations or AmerenUE's response.

The Commission has reviewed the arguments presented by Public Counsel and AmerenUE and makes the following determinations. The Commission will not make a determination regarding the appropriateness of AmerenUE's requested FAC until after the evidentiary hearing has been concluded. However, it is appropriate to provide notice to AmerenUE's electric service customers that AmerenUE has requested a FAC in order to afford those customers the opportunity to address and offer testimony regarding that request during public hearings. The Commission will adopt the public notice recommended by Public Counsel and include the additional language requested by AmerenUE. The

Commission will also include language in the notice to minimize witness confusion that could result from simultaneously web-casting public hearings.

The Commission also finds that the public hearing locations recommended by Public Counsel are reasonable and will be held. However, the Commission finds that there are three additional locations where public hearings should be held. Accordingly, to give the public an opportunity to comment, the Commission will set a total of fifteen local public hearings in AmerenUE's service territory.²

For all hearings beginning at 12:00 p.m., the Staff of the Commission will hold an informal question-and-answer session beginning at 11:30 a.m., the hearing will begin at 12:00 p.m., and will conclude when the last witness has testified. For all hearings beginning at 6:00 p.m., the Staff of the Commission will hold an informal question-and-answer session beginning at 5:30 p.m., the hearing will begin at 6:00 p.m., and will conclude when the last witness has testified.

IT IS ORDERED THAT:

16. No later than ten days prior to the local public hearings, Union Electric Company, d/b/a AmerenUE shall provide individual notice to each of its electric and natural gas service customers including all or the relevant portions of the notice as set out below.

NOTICE

AmerenUE has filed revised tariff sheets with the Missouri Public Service Commission (PSC) which would increase the company's electric service revenues by approximately \$360.7 million, and which would increase the company's natural gas service revenues by approximately \$10.8 million. For the average residential customer the proposed increase would be approximately \$6.00 per month for electric and \$6.00 per month for natural gas.

AmerenUE's electric rate filing includes a request to implement a fuel adjustment clause. A fuel adjustment clause, if approved by the Commission, would allow increases or decreases in fuel and purchased power costs occurring after base electric rates are set by the pending electric rate case to be passed through to customers as a separate line on customer's bills. Increases in fuel and purchased power costs above base electric rates would be applied to customer bills via a separate and additional charge and decreases would be applied to customer bills via a credit.
