A. Low Income Programs

- Q. In Staff's Report on Cost of Service filed on November 10, 2010, Staff recommended that the Company should be allowed to recover only fifty percent of the cost of the Economic Relief Pilot Program (ERPP) at the time based on Jimmy Albert's testimony. However, from discovery of information recently received from the Company, the Company has acquired a sufficient number of participates in their ERPP. The number of participants in the ERPP appears to be sufficient to request the cost recovery of deferred cost created because the new customers enrolled. Therefore, I would like to withdraw my previous recommendation on this matter, and now recommend, full recovery of the cost of the Economic Relief Pilot Program as requested.
