Dear Mr. Shortley:

This is to acknowledge Southwestern Bell Telephone Company d/b/a AT&T Missouri's receipt, on March 31, 2010, of your March 30, 2010, letter requesting negotiation of a successor interconnection agreement with AT&T Missouri, pursuant to Section 252(a)(1) of the federal Telecommunications Act ("the Act"). Based on AT&T Missouri's receipt of Global Crossing's request, Day 1 of the negotiations window is April 01, 2010. Days 135 and 160 are August 13 and September 07, 2010, respectively.

You also state in your March 30 letter that "Global Crossing is interested, in the context of such negotiations, to explore the possibility of porting, for the State of Missouri, the Global Crossing-BellSouth agreement currently in effect." As you know, however, AT&T/BellSouth Merger Commitment 7.1, is the lone basis on which Global Crossing would be able to request such a port, as the matter is not a duty or requirement imposed by Sections 251/252 of the Act. Accordingly, any communications between AT&T Missouri and Global Crossing regarding the subject of porting will not be "in the context of such negotiations," as your letter suggests, but rather will be separate and apart from our negotiations under the Act. If Global Crossing does wish to request a port of an interconnection agreement, it may do so by completing the Merger Commitment request form for porting located at https://clec.att.com/clec/shell.cfm?section=2621.
