1	JUDGE PRIDGEN: On the record, please.
2	Good morning. We're on the record in the
3	prehearing conference in File No. ER-2012-0024 in the
4	matter of the determination of carrying costs for the
5	phase-in tariffs of KCP&L Greater Missouri Operations
6	Company.
7	I'm Ron Pridgen. I'm the regulatory law
8	judge assigned to preside over this prehearing
9	conference. It is being held on September 22, 2011,
10	at 10:00 o'clock in the morning.
11	We are in the Governor Office Building in
12	Jefferson City, Missouri. I would like to get
13	entries of appearance from counsel, please, and if I
14	could begin with KCP&L-GMO, please.
15	MR. FISCHER: Let the record reflect the
16	appearance of James M. Fischer on behalf of KCPL
17	Greater Missouri Operations Company, and my contact
18	information's on the written form.
19	JUDGE PRIDGEN: Mr. Fischer, thank you.
20	On behalf of the Staff of the Commission,
21	please.
22	MR. WILLIAMS: Nathan Williams, P.O. Box
23	360, Jefferson City, Missouri 65102.
24	JUDGE PRIDGEN: Mr. Williams, thank you.
25	On behalf of Ag Processing, Inc., please.

1	MR. CONRAD: Your Honor, on behalf of
2	Ag Processing, please note that we are specially
3	appearing this morning through Stuart W. Conrad and
4	Jeremiah Finnegan, both with the law firm Finnegan,
5	Conrad & Peterson, Kansas City, 3100 Broadway,
6	Suite 1209, Kansas City, Missouri 64111. I have,
7	your Honor, provided my and Mr. Finnegan also
8	address and vital statistics to the reporter.
9	JUDGE PRIDGEN: Okay. Mr. Conrad, thank
10	you. Mr. Finnegan, thank you.
11	On behalf of the Office of the Public
12	Counsel, please.
13	MR. MILLS: On behalf of the Office of the
14	Public Counsel and the public, my name is Lewis
15	Mills. My address is P.O. Box 2230, Jefferson City,
16	Missouri 65102.
17	JUDGE PRIDGEN: Mr. Mills, thank you.
18	Is there anyone else wishing to enter an
19	appearance?
20	(No response.)
21	JUDGE PRIDGEN: All right. Hearing none,
22	and I think as Mr. Conrad and I discussed before
23	going on the record, there were several counsel who
24	had e-mailed, and I think one or two have called and
25	left messages who had no intention to appear at the

1	prehearing conference this morning.
2	Is there anything that counsel would need
3	to bring to my attention?
4	MR. WILLIAMS: Judge, I don't know if it
5	needs to be brought to your attention, but I believe
6	there have been a number of motions to withdraw from
7	the case. Staff has no opposition to any of those.
8	JUDGE PRIDGEN: And I don't know if a full
9	ten days has run and I don't know if the parties wish
LO	to wait the full ten days before replying or parties
L1	know
12	MR. CONRAD: Yes. Your Honor, please,
13	subject to our special appearance, we have no
L 4	objection to either the request for excuse or to any
L5	of the requests to withdraw that we have seen.
L 6	JUDGE PRIDGEN: All right. Mr. Conrad,
L7	thank you.
L8	Is there anything further from counsel
L 9	before I let the parties talk? Mr. Fisher.
20	MR. FISCHER: Judge, I would just
21	wonder if the Commission has what their calendar

looks like, whether there's any date that would be preferable for the Commission if we were to have a hearing or anything along that line that you can direct us to?

1	JUDGE PRIDGEN: I glanced at the calendar
2	this morning, and I don't recall anything I don't
3	know how much time the parties need to get ready or
4	how many days the parties are going to anticipate a
5	hearing going.
6	You're welcome I'll be glad to let you
7	look at the calendar up on the ninth floor,
8	obviously. Like I said, I glanced at it earlier this
9	morning, and I've already forgotten what I saw.
10	MR. FISCHER: I think Mr. Williams and I
11	took a quick glance, and there seemed to be something
12	on October 11.
13	JUDGE PRIDGEN: I'm sorry. I don't
14	recall. I'll be here if you want, once we go off
15	the record, I'll be glad to go upstairs
16	MR. FISCHER: I just doesn't it's
17	not that important.
18	MR. CONRAD: While we're on the record
19	MR. WILLIAMS: You can see what I'm going
20	to show him here (indicated).
21	MR. CONRAD: I haven't looked at the
22	schedule that's been handed to me. We would need to
23	have, I would say, time, at least under the
24	Commission's usual discovery rules. I don't think we
25	have seen a specific discovery order that's been

- 1 issued here. I'd want to have a little bit of time for 3 a couple rounds of DRs. I think that would push us beyond an October time frame, but beyond that I'm not 5 anticipating, you know, huge difficulties, if there's some time after that. 6 7 JUDGE PRIDGEN: Okay. Very good. And 8 also, I mean, I know I have another prehearing this 9 afternoon, and so whatever days those parties might 10 want might collide with whatever days you're 11 choosing, so my guess is, whoever grabs days first on the calendar --12 13 MR. WILLIAMS: It sounds like it's wide 14 open. What I believe Mr. Fisher was alluding to was 15 whenever I look at Outlook of the RLJ calendar, it 16 showed apparently somebody maybe tentatively scheduled October the 11th for an evidentiary hearing 17 18 in this case. 19 JUDGE PRIDGEN: I don't recall that I 20 have --MR. WILLIAMS: You're saying there's no 21 22 significance to that, I gather?

17	MR. CONRAD: I think that would be
18	doable.
19	JUDGE PRIDGEN: Yeah, I just plan to
20	work from there and see what you file on or
21	before the 29th.
22	MR. CONRAD: That might be helpful to
23	him, some insight as to open stage for a
24	potential hearing.
25	JUDGE PRIDGEN: Certainly. If you'd

1	like, you're welcome to look, or I'm happy to go
2	up there and look and report back, and give you
3	open days, conflicts, whatever you'd like.
4	Anything else from counsel before we
5	go off the record?
6	JUDGE PRIDGEN: (No response.)
7	JUDGE PRIDGEN: All right.
8	Mr. Mills, if you'll just stay on the phone and
9	not disconnect, I'll move the phone here in just
10	a moment and let the parties talk.
11	MR. MILLS: All right. Thank you,
12	Judge.
13	JUDGE PRIDGEN: You're welcome.
14	If there's nothing further, we'll go
15	off the record in the prehearing conference in
16	File No. ER-2012-0024. Thank you.
