True-Up Direct Testimony of Erin L. Maloney

- A. Yes the allocation percentage assigned to L&P increased approximately 1.5% and likewise MPS's decreased approximately 1.5% due to the fact that L&P experienced a higher rate of load growth than MPS between the end of the test year and the true-up date.
- Q. What megawatt amounts have been assigned to L&P and MPS from the latan 2 generation plant for the purpose of re-calculating the allocation factors for this true-up?
- A. As in Staff's direct filing, Staff has assigned 65.36% (100 of 153 MWs) of the available latan 2 generation to L&P and 34.64% (53 of 153 MWs) of the available latan 2 generation to MPS.
 - Q. Does this conclude your true-up testimony?
