#### ARTICLES OF INCORPORATION

OF

The undersigned natural person of the age of Twenty-one years or more for the purpose of forming a Corporation under The General and Business Corporation Law of Missouri adopts the following Articles of Incorporation:

#### ARTICLE ONE

The name of the Corporation is: OZARK MOUNTAIN WATER COMPANY.

#### ARTICLE TWO

The address, including street and number, if any, of the Corporation's initial registered office in this state is: 626 Woodruff Building, Springfield, Missouri, and the name of its initial registered agent at such address is: Louis W. Cowan.

#### ARTICLE THREE

The aggregate number, class and par value, if any, of shares which the Corporation shall have authority to issue shall be: Thirty Thousand (30,000) shares of common stock with a par value of Ten (\$10.00) Dollars each.

- (b) To own, hold, construct, buy, sell, deal in, mortgage, operate and maintain waste water and sewage disposal systems, including the furnishing of sewage disposal service to the public.
- (c) To own, hold, buy, sell, rent, lease, deal in, mortgage, operate and manage real estate and real properties of every kind and character.
- (d) To construct, build, repair, maintain and otherwise engage in the business of constructing, erecting, building, repairing and maintaining water distribution systems, and waste water and sewage disposal systems and related facilities incidental to

or necessary in the operation of a water distribution system and a waste water and sewage disposal system.
