On May 22, 2018, the Commission's Staff filed a report and recommendation regarding Summit Natural Gas of Missouri, Inc.'s ("Summit") application for a certificate of convenience and necessity. On May 31, 2018, Summit filed a request for an extension of time until June 21, 2018 to respond to Staff's recommendation, which the Commission granted. On June 21, 2018, Summit filed a second request for extension of time, stating that it needs additional time to discuss this matter with the other parties. Summit represents that the other parties do not object to this request. The Commission finds the request reasonable and will grant the request.

### THE COMMISSION ORDERS THAT:

1. Summit Natural Gas of Missouri, Inc.'s request for an extension of time filed on June 21, 2018, is granted. The deadline for responding to Staff's recommendation is extended until no later than July 5, 2018.
