Dear Mr. Chairman and Commissioners,

On behalf of my companies, Microfinish Co. Inc and Microfinish IPC, LLC, I write in support of Spire STL Pipeline's application for a Temporary Emergency Certificate. This pipeline is critical infrastructure for the St. Louis region that provides reliable natural gas supply to hundreds of thousands of families and numerous businesses.

The potential loss of the STL Pipeline —with the fast-approaching winter heating season —could result in the curtailment of service to many of Spire's commercial and industrial customers. As a transport customer of Spire, our business may have to seriously reduce or suspend operations if there is any curtailment in natural gas service.

We do zinc and nickel/chrome plating at our facilities. Lossing the gas supply to keep our buildings and process tanks would be catastrophic the facility. If the lines with solutions, would freeze, it would cost us tremendous down time and expense, possibly to the point we could not recover. I am not being dramatic, it's the truth. Failure to supply items like the safety belt parts would cause a tremendous supply line issues for the automotive industry, as well as DOD, and other vital industries.

In February, we saw how Winter Storm Uri disrupted energy supply to millions of homes and businesses across the country. St. Louis did not experience the same hardship because the STL Pipeline ensured families and businesses had the natural gas needed for heating, cooking, hot water and industrial use. Without the STL Pipeline in service this winter, we won't be this fortunate.

Operating a business is challenging at any time, but we have faced unprecedented obstacles as a result of the global pandemic. If we are also forced to reduce or cease operations due to a lack of natural gas service this winter, we'll experience significant impacts on our business and <u>100 employees</u>. And with potential curtailment and outages extending beyond our own operations to other businesses, negative economic consequences for the entire St. Louis business community – and the region – could likely occur.

Minimizing uncertainty and risk is *crucial* to optimizing our operations and minimizing impact to our business. Having confirmed availability and access to the reliability of the STL Pipeline is critical for both our shortand long-term business planning. Your ability to remove this uncertainty through -- and beyond -- the coming spring is key.

I urge you to quickly take action and to grant a certificate for the STL Pipeline to keep our businesses operational and families warm. Hundreds of thousands of residents across the St. Louis region rely on this critical infrastructure, and there will be potentially devastating consequences if it is forced to shut down.

I have been buying the company over the last 20 years and have just made my last payment. It would be devastating to me personally, to have put into jeopardy, a dream I have worked so hard for, be dashed, when it can so easily be avoided. I
