## ORDER GRANTING EXPEDITED TREATMENT AND APPROVING COMPLIANCE TARIFF

Issue Date: July 16, 2007

Effective Date: July 23, 2007

On June 28, 2007, the Commission issued an Order Denying Applications for Rehearing, Granting Clarification, and Correcting Order Nunc Pro Tunc. In that order, the Commission clarified its previously issued Report and Order to specify the net salvage percents to be used in calculating the depreciation rates for specific plant accounts. The Commission also ordered AmerenUE to file revised tariff sheets to reflect the revised calculations.

Union Electric Company, d/b/a AmerenUE, filed a tariff intended to comply with the Commission's Order on July 6. Along with its tariff, AmerenUE filed a motion asking the Commission to expedite its consideration of that tariff so it may go into effect on July 23, the date AmerenUE's billing system is able to apply the revised rates to customers' bills.

On July 10, the Commission issued an order directing its Staff to file a recommendation regarding AmerenUE's compliance tariff by July 13. That order also required that any other party wishing to file a recommendation regarding the tariff do so by July 13.

The Commission's Staff filed its recommendation regarding AmerenUE's compliance tariff filing and motion for expedited treatment on July 13. No other party filed a recommendation. Staff concludes that the tariff complies with the order, and recommends the Commission approve the compliance tariff to be effective on July 23.

The Commission has reviewed the proposed tariff and Staff's Recommendation. For good cause shown pursuant to Section 393.140(11), RSMo 2000, the Commission concludes that the submitted compliance tariff is consistent with the Commission's order and should be approved to become effective for service rendered on and after July 23.

## IT IS ORDERED THAT:

1. The Motion for Expedited Treatment filed by Union Electric Company, d/b/a AmerenUE, is granted.

2. The proposed electric service tariff submitted under Tariff File No. YE-2008-0012 by Union Electric Company, d/b/a AmerenUE is hereby approved, effective on and after July 23, 2007. The specific tariff sheets approved are:
