MOTION TO FILE ITS REPLY BRIEF AND MOTION TO STRIKE PORTIONS OF
AT&T'S AND WCOM'S INITIAL BRIEFS ONE DAY OUT OF TIME**

Comes now Southwestern Bell Telephone, L.P., d/b/a Southwestern Bell Telephone Company ("SWBT") and, for its Motion to File its Reply Brief and Motion to Strike Portions of AT&T's and WCOM's Initial Briefs One Day Out of Time, states as follows:

1. On Friday, August 23, 2002, both the Missouri Public Service Commission ("Commission") Data Center and Judge Roberts informed SWBT that since it was submitting its pleadings using the Electronic Filing & Information System ("EFIS"), SWBT no longer needed to submit paper copies of pleadings to the Commission.


2. On Monday, October 28, 2002, SWBT made multiple attempts to scan its documents into a PDF file format. However, SWBT experienced multiple scanning problems and was not able to scan the documents until after 4:00 p.m. on October 28, 2002. Scanning is a prerequisite to filing the documents using EFIS.

3. No party will be prejudiced if the Commission grants SWBT's Motion for Leave to File its Reply Brief and Motion to Strike Portions of AT&T's and WCOM's Initial Briefs One Day Out of Time because SWBT e-mailed a copy of its Reply Brief and Motion to Strike Portions of AT&T's and WCOM's Initial Brief to each of the parties.

Wherefore, Southwestern Bell Telephone, L.P., d/b/a Southwestern Bell Telephone Company prays that the Commission grant its Motion for Leave to File Its Reply Brief and Motion to Strike Portions of AT&T's and WCOM's Initial Briefs One Day Out of Time, together with any further and additional relief the Commission deems just and proper.
