NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: September 23, 2021

On August 9, 2021, Union Electric Company d/b/a Ameren Missouri asked for an amendment to its Rider PGA tariff. In response to the extreme cold of February 2021, Ameren Missouri asks to extend the Actual Cost Adjustment recovery period beyond 12 months for up to 36 months, for good cause shown. Ameren Missouri filed an implementing tariff on August 26, 2021, which bears a September 25, 2021 effective date.

Staff filed a recommendation on September 1, 2021, asking the Commission to approve the tariff, or allow it to go into effect by operation of law. No party has objected.

Tariff No. YG-2022-0043 will be allowed to go into effect by operation of law on September 25, 2021.
