NOTIFICATION OF ELECTION OF WAIVERS ON BEHALF OF THE FAIRPOINT COMPANIES

COME NOW, FairPoint Communications Missouri, Inc. d/b/a FairPoint Communications, ExOp of Missouri, Inc. d/b/a FairPoint Communications, ST Long Distance, Inc. d/b/a FairPoint Communications Long Distance and FairPoint Carrier Services, Inc. (collectively, the "FairPoint Companies") and each of the FairPoint Companies hereby notifies the Commission of its election to waive and be exempt from the application and enforcement of certain commission rules and statutes, pursuant to Sections 392.245.5(8), 392.420 and 392.461, RSMo, as amended by HB 338.

Background of the FairPoint Companies

1. FairPoint Communications Missouri, Inc. d/b/a FairPoint Communications ("FairPoint Missouri") is a Missouri corporation with its principal Missouri office at 192 West Broadway, Peculiar, Missouri 64078. FairPoint Missouri is authorized to do business in Missouri¹ and its fictitious name is duly registered with the Missouri Secretary of State.² FairPoint Missouri is a "local exchange telecommunications company" and a "public utility", and is duly authorized to provide "telecommunications"

service" within the State of Missouri, as each of those terms is defined in Section 386.020. RSMo 2000.

- 2. ExOp of Missouri, Inc. d/b/a FairPoint Communications ("ExOp") is a Missouri corporation with its principal Missouri office at 303 North Jefferson, Kearney, Missouri 64060. ExOp is authorized to do business in Missouri³ and its fictitious name is duly registered with the Missouri Secretary of State. ExOp is an "alternative local exchange telecommunications company" which is duly authorized to provide "telecommunications service" within the State of Missouri, as each of those terms is defined in Section 386.020, RSMo.
- 3. ST Long Distance, Inc. d/b/a FairPoint Communications Long Distance ("FCLD") is a Delaware corporation with its principal office at 908 W. Frontview, Dodge City, Kansas 67801. FCLD is authorized to do business in Missouri⁵ and its fictitious name is duly registered with the Missouri Secretary of State. FCLD was granted a certificate of service authority to provide intrastate interexchange telecommunications services and was classified as a competitive telecommunications company on May 30, 2006, in Case No. TM-2006-0306.
- 4. FairPoint Carriers Services, Inc. ("FCS") is a Delaware corporation with its principal office at 908 W. Frontview, Dodge City, Kansas 67801. FCS is authorized to
