On August 9, 2021, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. In response to the extreme cold of February 2021, Ameren Missouri asks for an amendment to its Rider PGA tariff to extend the Actual Cost Adjustment recovery period beyond 12 months for up to 36 months, for good cause shown. Because Ameren Missouri's Purchased Gas Adjustment tariff is due for an annual adjustment on November 1, Ameren Missouri asks for an order's effective date of no later than October 1 for this file.

The Commission will order its Staff to file a Recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than September 1, 2021.
2. This order shall be effective when issued.
