## CHARITON VALLEY COMMUNICATIONS CORPORATION SUPPLEMENT TO APPLICATION FOR EXPANSION OF DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

COMES NOW Chariton Valley Communications Corporation ("Chariton Valley"), and hereby supplements its October 19, 2018 Application for Expansion of Designation as an Eligible Telecommunications Carrier, as follows:

1. On May 1, 2013, when Applicant Chariton Valley Communications
Corporation's legal name was Chariton Valley Telecom Corporation, the Commission
granted ETC status to Chariton Valley on May 1, 2013 in case TA-2012-0128. On
December 31, 2016, affiliate Chariton Valley Communication Corporation was merged
into Chariton Valley Telecom Corporation, the surviving corporation, which surviving
corporation was renamed Chariton Valley Communications Corporation. See
Attachment F hereto, the Missouri Secretary of State Certificate of Merger. By Order
dated December 23, 2016 in CN-2017-0174, this Commission recognized the name
change from Chariton Valley Telecom Corporation to Chariton Valley Communications
Corporation. Chariton Valley Communications Corporation hereby commits to solely

conduct business using the correct current legal name, Chariton Valley Communications Corporation, and will not use additional service or brand names.

- 2. Chariton Valley will offer voice telephony as a standalone service throughout its designated service area.
- 3. Chariton Valley intends to provide service throughout the proposed high-cost designated service area utilizing its own facilities. Customers in the Census blocks, as set forth in Attachment A1 to the original Application, will be served by facilities constructed in the manner, and by the dates, as set forth in Attachment G hereto.

  Attachment G is Exhibit 4 to Chariton Valley's Long-Form 683 Application filed with the FCC. Attachment G sets forth Chariton Valley's technology and system design description, the network to be built, and other information. This information explains how Chariton Valley intends to provide service throughout the service area using awarded CAF Phase 2 funds, including areas where Chariton Valley currently lacks facilities or network coverage. The FCC has provided that Carriers such as Chariton Valley may rely upon the information and certifications submitted in this Application. See pages 2-6 of the FCC Public Notice DA 18-274.
  - 4. An affidavit supporting this Supplement to the original Application follows.

WHEREFORE, on the bases of the foregoing Chariton Valley respectfully requests that the Commission grant this Application and expand Chariton Valley's current ETC designation to include the additional service area census block groups awarded Chariton Valley in the CAF II Auction for purposes of high-cost support, and to expand Chariton Valley's current ETC designation to include the state of Missouri for

purposes of lifeline and disabled support, to certify such designation to the FCC, and for such other orders as are deemed necessary or convenient in this matter.
