## ORDER ESTABLISHING TIME TO RESPOND

On August 25, 2021, Liberty Utilities (Midstates Natural Gas) Corp. (Liberty-Midstates) applied for an accounting authority order permitting it to track and defer in a regulatory asset beginning February 2021, all incremental costs and other financial impacts of Winter Storm Uri. Symmetry Energy Solutions, LLC (Symmetry) applied to intervene on September 17, 2021 and Liberty-Midstates objected to that application on September 27, 2021.

Before ruling on Symmetry's application to intervene, the Commission will offer an opportunity to respond to Liberty-Midstates' objection to that application.

### THE COMMISSION ORDERS THAT:

1. Any response to Liberty-Midstates' objection to Symmetry's application to intervene shall be filed no later than October 7, 2021.
2. This order shall be effective when issued.
