ORDER DENYING RE-HEARING

Chantel R. Muhammad filed comments¹ on the recommended report and order.² Those comments were seven days out of time³ and two days after the Commission issued the final report and order.⁴ Nevertheless, to give Mr. Muhammad's arguments a full consideration, the Commission is treating Mr. Muhammad's comments as an application for re-hearing.

The Commission grants an application for re-hearing if "in its judgment sufficient reason therefor be made to appear"⁵ and, under that standard, the Commission will deny the application. This order exhausts the Commission's authority over the dispute
