ORDER DIRECTING FILING AND SETTING DATE FOR EVIDENTIARY HEARING

Issue Date: September 21, 2015

Effective Date: September 21, 2015

On September 11, 2015, Commerce Tower Group, LLC ("CTG") filed a complaint with the Missouri Public Service Commission ("Commission") against Veolia Energy Kansas City, Inc. ("Veolia"), which was amended on September 15, 2015. On September 18, 2015, CTG filed a motion for expedited treatment, alleging that Veolia has refused to communicate with CTG in violation of its tariffs regarding relocation of certain steam equipment, and that schedule delays to CTG's building renovation due to Veolia's refusal to permit that relocation will cause CTG to incur damages of \$500,000 per month. CTG requests that the Commission schedule an evidentiary hearing solely on the issue of relocation of the Veolia steam equipment no later than October 2, 2015. The Commission will provide an opportunity for Veolia and other parties to object or respond to the motion for expedited treatment and schedule an evidentiary hearing on the issue of the relocation of the steam equipment.

THE COMMISSION ORDERS THAT:

1. Any party that wishes to object or respond to Commerce Tower Group, LLC's Motion for Expedited Treatment Regarding the Relocation of Veolia's Steam Equipment, shall do so no later than September 24, 2015.

2. An evidentiary hearing is scheduled for October 1, 2015, beginning at 9:00 a.m. This hearing will only address the issue of the relocation of the Veolia steam equipment. The hearings will be held in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The hearings will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person requiring additional accommodations to participate in the hearing shall call the Missouri Public Service Commission's Hotline at 800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

3. The requirement in Commission Rule 4 CSR 240-2.130 that parties pre-file prepared testimony is waived. The Commission orders that all testimony at the hearing on October 1, 2015 shall be taken live rather than prepared in advance.

4. The parties shall agree upon and Commerce Tower Group, LLC shall file a list of the witnesses to appear at the hearing, the order in which they will be called, the order of party cross-examination for each witness, and the order of opening statements. This information shall be filed no later than September 28, 2015.

5. All parties shall bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. The party offering it must bring, in addition to the copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel.
