## State of Missouri's Test Year and True-up Recommendation

Comes Now the State of Missouri and pursuant to the Commission's Order of July 11, 2006 files its test year and true-up recommendation in the above referenced matter.

The State of Missouri has no objection to the use of the test year requested by

Union Electric in the Direct Testimony of Gary S. Weiss. The State does not object to the
true-up of known and measurable items through January 1, 2007. However, at this early
stage of the proceeding the State is not in a position to agree that the list of items included
in the direct testimony of witness Weiss are the only items worthy of true-up
consideration. Given that, the State requests that the Commission issue an Order
directing the parties to agree upon a package of true-up items at some time in the future
after more investigation of Union Electric's rate request has been under taken.

WHEREFORE, the State of Missouri requests the Commission issue its Order approving Union Electric's requested test year, issue an Order allowing the true-up of a package of known and measurable items through January 1, 2007 and directing the parties to file at a date in the future the agreed upon package of true-up items.
