NOTIFICATION OF ELECTION OF WAIVERS MARK TWAIN COMMUNICATIONS COMPANY

- 1. On August 28, 2008, §392.245.5(8) and §392.420 RSMo were amended by H.B. 1779, allowing telecommunications companies to elect waivers of certain provisions of statutes and regulations.
- 2. On August 28, 2010, 2010 H.B. 338 added §392.461, which provided for further election of waivers of certain provisions of statutes and regulations.
- 3. In earlier proceedings in this docket Staff has requested that all future elections of waivers be filed in this docket for administrative efficiency.
- 4. Company, as a CLEC, has received certain waivers in the past. Company hereby notifies the Commission that it elects waiver of the application and enforcement of all statutes and rules listed in paragraph 4 of Staff's Motion of October 18, 2011 filed in this docket, to the extent not already waived for the Company.
