

4 CSR 240-125.050 Limited Use Installer License

PURPOSE: This rule establishes licensing guidelines for limited use installer licenses for manufactured home installers.

- (1) To be licensed as a manufactured home limited use installer, an applicant shall submit to the commission a completed application, signed and dated by the applicant, together with the required \$150 fee and proof of general liability and workmen's compensation insurance. A limited use installer license allows the holder to perform all of the work performed by a licensed installer under the supervision of a licensed installer;
- (2) A limited use installer license shall be valid for a period of 180 days and may be renewed one time; and
- (3) If needed, the commission may contact any person or entity to verify the experience of an applicant.

PUBLIC ENTITY COST: This proposed rule will not cost state agencies or political subdivisions more than \$500.00 in the aggregate.
