ORDER DIRECTING RESPONSE TIMES FOR DATA REQUESTS

On December 10, 2021, Ozarks Medical Center d/b/a Ozarks Healthcare filed a complaint with the Missouri Public Service Commission (Commission) against Summit Natural Gas of Missouri, Inc. (SNGMO). On February 17, 2022, all of the parties to the case: Ozarks Healthcare, SNGMO, the Staff of the Commission (Staff), and the Office of the Public Counsel (OPC) (collectively, "the Parties"), filed an agreed-to proposed procedural schedule.

The filed proposed schedule sets the response times to data requests at five business days, beginning February 7, 2022. That date will occur prior to the adoption of the full procedural schedule, thus the Commission will, on its own motion, set the response times to data requests at fourteen days beginning February 24, 2022.

THE COMMISSION ORDERS THAT:

1. Beginning February 24, 2022, the response time for all data requests shall be five (5) business days, and the responder will have three (3) business days to object or to notify the requesting party that more than five (5) business days will be needed to provide the requested information.

2. This order shall be effective when issued.
