On the 20th day of October, Regulatory Law Judge, Cherlyn D. Voss, issued the following order:

1. On or before October 30, 2006, the Missouri Retailers Association will file a supplement to its application to intervene out of time indicating why it was unable to determine whether to intervene in this case until October 12, 2006, but was unable to determine that it should seek intervention in Case No. ER-2007-0002 on September 8, 2006.
2. This order shall become effective on October 20, 2006.

Supplement to Missouri Retailers Application to Intervene in GR-2007-0003 Out of Time


The Missouri Retailers Association (MRA) was seeking to reduce the cost of intervention since the Association does not have budgeted funds for such interventions, members are solicited for funds to intervene.

The MRA polled its members after the commission issued an order granting application to intervene in Case No. ER-2007-0002, who thought that the Association should participate in both of the dockets, Case No. ER-2007-0002 (Electric) and Case No. GR-2007-0003 (Gas).

The MRA will have no witnesses.

Approval of intervention in Case No. GR-2007-0003 will permit the MRA to join in settlement discussions which could be detrimental to the MRA if not permitted to participate in such discussions.


