Section 536.200.3, RSMo, requires the Commission to review the fiscal note or estimated cost declaration attached to its 2020 amendment of Commission Rules 20 CSR 4240-40.020, 40.030, 40.033, and 40.080, at the end of the first full fiscal year following the implementation of the amended rules.

As part of its review, the Commission will invite interested stakeholders to offer comments about the accuracy of the fiscal impact stated in the fiscal notes or estimated cost declaration that accompanied the rulemaking.

THE COMMISSION ORDERS THAT:

1. Comments regarding the actual cost of compliance shall be filed with the Commission by July 20, 2022.
2. The Commission's Data Center shall provide a copy of this order to all persons who filed comments regarding the rule, and to all entities subject to natural gas safety regulation by the Commission.
3. This order shall be effective when issued.




