#### ORDER DIRECTING FILING OF AUGUST DATES

Chantel R. Muhammad informed the Commission that, as to a hearing date,<sup>1</sup> "The first full week in July (after the 4<sup>th</sup>) is fine." Monday July 4 is a state holiday. The first full week in July after July 4 is the week of July 11, 12, 13, 14, and 15, 2016.
