The undersigned parties state the following to the Missouri Public Service Commission as their *Status Report*:

1. At the parties' request, the Commission issued its *Order Suspending Procedural Schedule* on February 24, 2022. In addition to suspending the remaining procedural schedule (including the discovery schedule), the Commission directed that the "parties shall file either a stipulation and agreement, or a status report, by March 8, 2022." Subsequently, again at the parties request, the Commission issued its *Order Directing Filing* on March 8, 2022, directing that "the parties shall file either a stipulation and agreement, or a status report, by March 18, 2022."

2. The parties report that the process of producing and filing a stipulation and agreement continues. A document has been exchanged among the parties and comments are being gathered. Further, the calculations related to inputs are being finalized.

3. As this process continues, the Parties again ask that the procedural schedule (including the discovery schedule) remain suspended and that the Commission further direct the parties to either file a stipulation and agreement or a status report by March 29, 2022.

WHEREFORE, the undersigned parties unanimously and respectfully ask the Commission to allow the procedural schedule in the referenced matters to remain suspended as described herein.
