NOTICE OF FILING

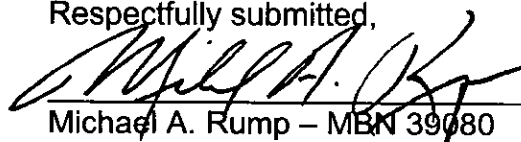

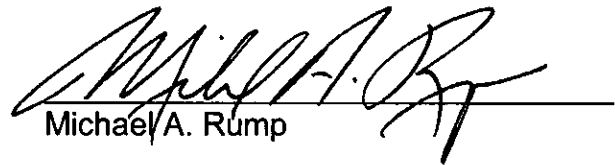
