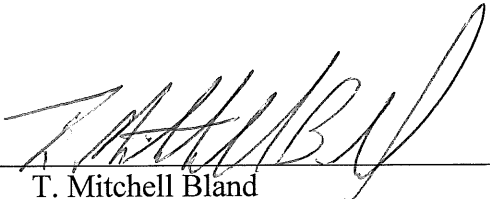
AFFIDAVIT

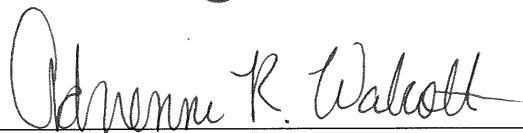
