**ORDER GRANTING ADDITIONAL EXTENSION OF TIME
TO FILE STAFF RECOMMENDATION**

On April 27, 2023,¹ Spire Missouri Inc. (Spire) filed an application that seeks a certificate of convenience and necessity for a natural gas distribution system in Johnson County, Missouri.

On April 28, the Commission issued an order that, among other things, directed the Staff of the Commission (Staff) to file a recommendation regarding Spire’s application by June 12, or to file a request for an extension of time. On June 7, Staff filed a timely request for an extension of time to file its recommendation, and the Commission extended the deadline to July 12.

On July 10, Staff filed its *Motion for Additional Extension of Time to File Staff Recommendation*. In its motion, Staff requested an extension of time to August 14 to file its recommendation due to recent additional data requests and the need for time to analyze the responses to those data requests.

The Commission finds the motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's *Motion for Additional Extension of Time to File Staff Recommendation* is granted.
2. Staff shall file its recommendation on or before August 14, 2023.
3. This order shall be effective when issued.
