On December 19, 2016, Laclede Gas Company (Laclede), on behalf of itself and its Missouri Gas Energy (MGE) operating unit, filed a response in opposition to The Office of the Public Counsel's (Public Counsel) December 9<sup>th</sup> Motion to Deny Rate Increases filed on December 9, 2016. Laclede requests that the Commission deny Public Counsel's motion and direct Laclede and MGE to file tariff's complying with the recommendations of the Staff of the Missouri Public Service Commission (Staff). In the alternative, Laclede asks that two issues, incentive compensation and updating, be stricken from the hearing issues.

The Commission will direct any party wishing to respond to file a response no later than December 23, 2016. This order shall not alter the previously ordered procedural schedule. The Commission also advises the parties to be prepared to argue this motion at the time set for hearing on January 3, 2017.
