ORDER DIRECTING KANSAS CITY POWER & LIGHT COMPANY
TO PROVIDE CUSTOMER NOTICE

On February 1, 2006, Kansas City Power & Light Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for electrical service provided in its Missouri service area. On February 3, the Commission ordered the Office of the Public Counsel to submit a proposed customer notice no later than March 28, and allowed parties until April 4 to object.

OPC filed its proposed customer notice on March 28, and no party objected. The Commission will order KCP&L to send its customers notice of the proposed rate increase and the local public hearings as suggested by OPC.

IT IS ORDERED THAT:

1. Kansas City Power & Light Company shall send its customers the following notice via billing insert, said notice scheduled to arrive at each customer's mailing address no later than August 14, 2006:

IMPORTANT NOTICE

Kansas City Power & Light Company has filed revised electric service tariff sheets with the Missouri Public Service Commission that would increase the company's Missouri jurisdictional annual gross revenues by \$57 million, or approximately 11.5%. For the average residential customer, the increase would be approximately \$7.06 per month.

The PSC will conduct local public hearings to solicit input from the company's customers. Two hearings will be held on August 24, 2006, at the Jackson County Courthouse Legislative Chamber, 415 East 12th Street, Kansas City, Missouri. One hearing will begin at noon, and one at 6:00 p.m. Prior to each hearing, the PSC's Staff will hold an informal question and answer session.

The PSC will also conduct evidentiary hearings at the PSC's offices, 200 Madison Street, Jefferson City, Missouri, on October 16-20 and 23-27, 2006, beginning at 8:30 a.m. If you wish to comment or secure information, you may contact the Office of the Public Counsel, P.O. The buildings where the hearings will be held meet the accessibility standards required by the Americans with Disabilities Act.
