ORDER CANCELING TRUE-UP HEARING AND ADMITTING CERTAIN
DOCUMENTS INTO EVIDENCE

On April 13, 2007, Union Electric Company, d/b/a AmerenUE, and the Staff of the Commission filed a joint notice indicating that they have reached an agreement on all true-up issues. AmerenUE and Staff asked that the true-up hearing, scheduled for April 19 and 20, be canceled. They also requested that the Commission accept into evidence the true-up direct testimonies and schedules of Gary S. Weiss, Stephen M. Rackers and Greg R. Meyers, as well as AmerenUE's Revised True-Up Accounting Schedules and Staff's Revised True-up Reconciliation. On April 16, Noranda Aluminum, Inc. filed a response indicating that it does not oppose cancellation of the true-up hearing.

On April 16, the Commission ordered that any party wishing to respond to the motion to cancel the true-up hearing and admit evidence do so no later than April 17. No such response has been filed. Since no party has opposed the cancellation of the true-up hearing, that hearing will be canceled. The previously filed true-up direct testimony and accounting schedules will be admitted into evidence. Staff has not yet filed the revised

true-up reconciliation referenced in the joint notice, so the Commission will not take any action regarding that prospective filing at this time.

IT IS ORDERED THAT:

1. The true-up hearing scheduled for April 19 and 20, 2007, is canceled.
2. The True-Up Direct Testimony of Gary S. Weiss, filed by AmerenUE, is marked as exhibit 132 and is admitted into evidence.
3. The Company's Revised True-Up Accounting Schedules, filed by AmerenUE, is marked as exhibit 133 and is admitted into evidence.
4. The True-Up Direct Testimony of Stephen M. Rackers, filed by Staff, is marked as exhibit 276 and is admitted into evidence.
5. The True-Up Direct Testimony of Greg R. Meyer, filed by Staff, is marked as exhibit 277 and is admitted into evidence.
6. The True-Up Direct Staff Accounting Schedules, filed by Staff, is marked as exhibit 278 and is admitted into evidence.
7. This order shall become effective on April 18, 2007.
