On May 25, 2022, the Commission approved a stipulation and agreement that resolved Constellation NewEnergy – Gas Division, LLC's complaint against Spire Missouri, Inc. d/b/a Spire. The stipulation and agreement provided that within ten business days of the effective date of the order approving the stipulation and agreement, the complainant would dismiss its complaint with prejudice.

The Commission's order approving the stipulation and agreement became effective on June 4, 2022, but Constellation NewEnergy – Gas Division, LLC has not yet dismissed its complaint. No other pleadings have been filed that would indicate the complaint remains active.

Commission Rule 20 CSR 4240-2.116(2) provides that the Commission may dismiss any case for lack of prosecution if no action has occurred for ninety days and no party has filed a pleading requesting a continuance beyond that time.
