On January 18, 2017, the Missouri Public Service Commission issued a Report and Order effective January 28, 2017, regarding Laclede Gas Company's applications to change its Infrastructure System Replacement Surcharges (ISRS) in its Laclede and Missouri Gas Energy service territories. The Office of the Public Counsel filed a timely application for rehearing in both cases on January 27, 2017.

Section 386.500.1, RSMo 2000, indicates the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the Office of the Public Counsel has not shown sufficient reason to rehear the order. The Commission will deny the application for rehearing.
