On July 28, 2021, the Commission directed its Staff to investigate concerns about serious service disruptions to Spire Missouri's provision of natural gas in the St. Louis area that might result from the shut-down of the Spire STL Pipeline due to a court challenge to the Federal Energy Regulatory Commission's (FERC's) authorization to operate that pipeline. In compliance with a Commission order, Spire Missouri has filed quarterly reports about its contingency planning regarding a possible shutdown since March 2022.

In its January 3, 2023 quarterly report, Spire Missouri reports that FERC has issued a permanent certificate to Spire STL Pipeline LLC, providing certainty for the continued operation of the pipeline. Consequently, Spire Missouri asks to be relieved of the obligation to file additional quarterly reports. No party has responded to Spire Missouri's request.

The Commission finds that further reports from Spire Missouri are not necessary and that this investigative file may be closed.

THE COMMISSION ORDERS THAT:

1. Spire Missouri is relieved of the obligation to file quarterly reports regarding

its contingency planning.

- 2. This file shall be closed.
- 3. This order shall be effective when issued.
