COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or the Company) and, in compliance with the above-referenced Commission rule, hereby files its annual report relating to vegetation management for 2021.

- 1. Summary of the Documentation Required by 4 CSR 240-23.030(6)(B):
- a. Identification of each circuit and substation where vegetation management work was performed: See attached file 2022 Distribution Circuits to show which circuits were maintained in 2022. See attached file AmerenAnnualTXWorkplan2022.CompletedWork for 138kV and above for work performed in 2022.
- b. The type of vegetation management performed including removal, trimming and spraying and methods used: See the general guidelines for removal, trimming and spraying and the methods that are used as described in the AmerenUE Vegetation Management Program and Practices document filed on July 1, 2008 in Case No. EO-2009-0012.
- one to six or more crew members depending on the work. Each contractor supervisor is typically responsible for six to twelve crews. See attached file *Example Crew Numbers* (6)(B)3HC for an example of one contractor only, for one month on distribution. The entire file(s), along with hard copies of corresponding timesheets, as discussed with staff, can be updated and supplied upon request.
- d. The date of activity: See attached files 2022 Distribution Circuits and AmerenAnnualTXWorkplan2022.Completed Work.

- e. Any safety hazards encountered: Due to the nature of vegetation management work on any given day, multiple safety hazards exist for each person engaged in the work. As part of Performance Management, Ameren Missouri required each vendor in the area of safety to:
 - (i) report occurrences that result in an OSHA Recordable;
 - (ii) develop annual safety action plans; and
 - (iii) have individual goals each year for OSHA Recordable.
- f. Any unexpected occurrence or accident resulting in death, life threatening or serious injury to a person assigned to perform vegetation management activities or the public: In 2022 there were 2 incidents resulting in a serious injury to a person assigned to perform vegetation management activities.
 - 2. Other information required by 4 CSR 240-23.030(6)(C):
- a. Expenditures for vegetation management in the preceding year: See attached file Vegetation Management Historical Tracker-2022.xlsx.
- b. Vegetation management budget for the current year: The 2022 budget for vegetation management on the transmission and distribution system is \$40.0M.
- c. Circuits, completion dates and miles trimmed in the preceding year: See attached file 2022 Distribution Circuits. The tab marked "2022 Completed Circuits" has all feeders that were completed in 2022 marked with completion dates in red. See also the sheet marked "Additional 2022 Maintenance." The total overhead distribution miles trimmed in 2022 was 4,197. See also attached file AmerenAnnualTXWorkplan2022.CompletedWork which shows a total of 1,234 circuit miles for all activities, as shown, were completed on lines rated at 138kV and greater.
- d. Circuits, completion dates and miles scheduled for the current year: See attached file 2023 Distribution Schedule. The total overhead distribution miles scheduled to be trimmed in 2023 is 4,132 miles. See also attached filed Ameren Annual TXW or kplan 2022. Scheduled Work which shows a
