REBUTTAL TESTIMONY OF CHRISTINA UMBRIACO ON BEHALF OF MATTHEW AND CHRISTINA REICHERT

- 1 Q: What is your name?
- 2 A: Christina Alys Umbriaco.
- 3 Q: Where do you live?
- 4 A: 2000 North Market Street, St. Louis, Missouri, 63106.
- 5 Q: What is your experience as an artist?
- 6 A: I always showed interest in art ever since I was a little girl. I studied photography,
- drawing, and painting all throughout high school and college from 2000-2003 (HS) and
- 8 2003-2008 (University of Utah). It has always been more of a side hobby rather than a
- 9 career focus.
- 10 Q: What is your estimate of the number of drawings and paintings that you have
- 11 prepared since high school?
- 12 A: 30 to 40.
- 13 Q: Please explain your drawing in Schedule CU-1?
- 14 A: This is a rendering to as an accurate scale as possible of the placement of the
- proposed transmission towers on the property of Matt and Tina Reichert. The intent is to
- show the impact of the towers on the landscape.
- 17 Q: What information was provided to you to prepare the drawing?
- 18 A: Tina Reichert provided the original photograph in Schedule CU-2, the photograph
- with informational markings in Schedule CU-3, the heights of the house, barn and trees,
- 20 the dimensions of the transmission towers as stated by Grain Belt, the watercolor by
- 21 Kristie Harper in Schedule CU-4 that shows the relative heights of the structures, and
- 22 Schedule SN-2 from the Testimony of Scott Nordstrom.

- 1 Q: Do you know where the photo was taken?
- 2 A: It was taken at the top of the embankment along Fort Orleans Avenue while
- 3 standing within the pipeline easements.
- 4 Q: Are you familiar with the area?
- 5 A: Yes, my husband and I have stayed at the Reichert's Bed and Breakfast three times
- 6 within the last three years.
- 7 Q: Please provide some information as to the perspective of the drawing.
- 8 A: The house, barn, and tower closest to the viewer are approximately equidistant
- 9 from the viewer. A tower would be located almost directly to the viewer's right out of
- sight of the picture.
- 11 Q: What heights were provided for the structures and trees?
- 12 A: The heights are 24 feet for the house, 19 feet for the barn, 150 feet for the lattice
- towers, 100 feet for the monopole tower, and 90 feet for the trees on the west boundary
- line.
- 15 Q: Where does your drawing differ from the photographs in Schedules CU-2
- 16 and CU-3?
- 17 A: I removed the trees that would be clear cut for the 200 foot wide easement. I also
- removed the trees that were preventing a clear view of the barn and house. This was
- 19 necessary to show the scale of the towers relative to the structures on the farm.
- 20 Q: What is your opinion from an artist's perspective of beauty, etc. about these
- 21 transmission lines?
- 22 A: That the lattice towers and transmission lines will greatly draw away from the

- 1 natural beauty exhibited on this land. They would be an offensive intrusion of man made
- 2 architecture to a place that is so exquisitely serene and breathtaking in its purest form.
- Would they detract from the experience of visiting the farm and staying at
- 4 the **B&B?**
- 5 A: Indeed, I know they would.
