**KCP&L GREATER MISSOURI OPERATIONS COMPANY'S
DEMAND-SIDE PROGRAM ANNUAL REPORT FOR 2017**

COMES NOW KCP&L Greater Missouri Operations Company ("GMO"), and pursuant to 4 CSR 240-20.093(8) and 4 CSR 240-3.161(5), files its Cycle 2 Demand-Side Program Annual Report for 2017 and states as follows:

1. Missouri Public Service Commission's ("Commission") Missouri Energy Efficiency Investment Act ("MEEIA") regulations require utilities with one or more approved demand-side programs to file a Demand-Side Program Annual Report no later than 60 days after the end of each calendar year. GMO's deadline is 90 days rather than 60 days following each calendar year, or program year in this case, pursuant to the Commission's March 8, 2017 *Order Approving Application to Modify Demand-Side Programs*.¹

2. **Exhibit 1 (HC)** to this pleading is GMO's Demand-Side Program Annual Report for its Cycle 2 MEEIA programs (an Excel Workbook having multiple tabs) for program year 1 that run from the period of April 1, 2016 to March 31, 2017. Tab 1 of this Exhibit is an index which sets forth the requirements of 4 CSR 240-3.163(5) and indicates where the information responsive to each specific requirement can be found. **Exhibit 2** is the Affidavit of Kimberly H. Winslow.
