- 1. - b. Jim Russo: Rate and Tariff Examination Supervisor, Water and Sewer Department. Mr. Russo holds a Bachelor of Science degree in Business Administration, with an emphasis in accounting. Mr. Russo has been with the Commission for over 13 years, serving in his present position since August 2004. His present job duties include tariff review and rate design functions for water and sewer companies.
- c. **Kim Bolin: Regulatory Auditor V.** Ms. Bolin holds a Bachelor of Science degree in Business Administration, with an emphasis in accounting. Before beginning work at the Commission, Ms. Bolin was employed by OPC as a Public Utility Accountant from September 1994 to April 2005. Her present job duties include performing audits and examinations of the books and records of public utilities operating within the State of Missouri
