ORDER DIRECTING FILING

The Commission suspended the procedural schedule for these cases at the request of the parties on February 24, 2022. The parties indicated they have reached a settlement in principle and asked the Commission to suspend the procedural schedule, including discovery schedules, to allow them time to produce and file a stipulation and

agreement consistent with their settlement. The parties initially indicated they would file either a stipulation and agreement or a status report by March 8. At the parties' request, the Commission extended that deadline to March 18, March 29, April 12, April 19, and again to April 27.

The parties filed a status report on April 27, explaining that they continue to work on a stipulation agreement and ask that the procedural schedule remain suspended. They ask that the Commission direct the parties to file either a stipulation and agreement or another status report by May 11. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The procedural schedule remains suspended, and the parties shall file either a stipulation and agreement, or a status report, by May 11, 2022.
2. This order shall be effective when issued.
