# ORDER DIRECTING FILING OF RECONCILIATION AND RESPONSES

Issue Date: February 22, 2017 Effective Date: February 22, 2017

The Commission issued its Order Denying Rehearing in this matter on February 1, 2017, effective that same date. The Office of the Public Counsel has stated its intent to appeal the Commission's order and, thus, a reconciliation is required.

The Commission directs its Staff to file a reconciliation that complies with Subsection 386.420.4, RSMo. The reconciliation shall be detailed and contain the dollar value and rate impact of each contested issue decided by the Commission. It shall also contain the class billing determinants used by the Commission to calculate the rates and charges approved by the Commission. Public Counsel, Laclede Gas Company, and Missouri Gas Energy shall each cooperate with the Commission Staff to aid them in producing the reconciliation if requested to do so.

The Commission will also set a deadline for the parties to submit written statements in response to the Staff's reconciliation.

### THE COMMISSION ORDERS THAT:

- 1. The Staff of the Public Service Commission shall file a reconciliation as set out above no later than Friday, February 24, 2017.
- 2. The other parties may submit written statements with regard to Staff's filing no later than 10:00 a.m. February 28, 2017.
  - 3. This order shall be effective when issued.
