## RANDALL AND ROSEANNE MEYER'S RESPONSE TO UNITED FOR MISSOURI'S MOTION TO DISMISS

Randall and Roseanne Meyer (Meyers) file this Response to the Motion to Dismiss by United for Missouri (UFM). The Meyers state the following:

- 1. On, May 16, 2014, The Missouri Public Service Commission (PSC) issued its

  Order Setting a Procedural Conference that set a procedural conference for 2:00 p.m. on May 28
  in the offices of the PSC in Jefferson City, Missouri.
- 2. The Order required that all parties or their representatives attend the conference in person or by telephone.
  - 3. The Meyers received personal electronic service of the Order.
- 4. The Meyers' representative, Gary Drag, inadvertently missed the start time of the conference.
  - 5. The representative dialed into the conference at 2:24 p.m. Central Standard Time.
- 6. There was no apparent mechanism in place to record the representative's presence on the conference call if dialing in late.

7. The representative was unsure of the procedure to notify the Administrative Law

Judge of his presence without disrupting the ongoing discussions, during the break, or at the con-

clusion of the conference.

8. The representative attended the conference until its end at approximately 4:37

p.m.

9. Regulation 4 CSR 240-2.116(3) states that a "party may be dismissed from a case

for failure to comply with any order issued by the commission, including failure to appear at any

scheduled proceeding such as a public hearing, prehearing conference, hearing, or mediation ses-

sion."

10. The use of "may" in 4 CSR 240-2.116(3) grants the PSC discretion in dismissing

a party for failure to comply with its order. State Ex Rel. Pub. Counsel v. Pub. Service Comm'n,

274 S.W.3d 569, 584 (Mo. Ct. App. W.D. 2009).

11. The Meyers were in compliance with Order with the exception of the slightly

delayed attendance at the conference.

Therefore, the Meyers respectfully request that the PSC deny UFM's Motion to Dismiss

the Meyers as a party.
