The Office of Public Counsel's ("OPC") has filed Recommendations in the above-styled cases. That recommendation states that, in light of a recent Court of Appeals opinion, Spire Missouri, Inc., f/k/a Laclede Gas Co. and Missouri Gas Energy, ("Spire") has over-collected a certain amount of money which should be applied against the rate base of yet two other cases, GR-2017-0215 and GR-2017-0216. Both Spire and the Staff of the Commission have requested a technical conference to further discuss how to proceed.

The Commission will order the parties to meet and confer in a technical conference, and to report back to the Commission how they believe the Commission should proceed.

**THE COMMISSION ORDERS THAT:**

1. The parties shall meet and confer in a technical conference and shall file pleadings as ordered above no later than April 30, 2018.
2. This order shall be effective when issued.


