ORDER DIRECTING FILING

On September 30, 2016, Laclede Gas Company and Missouri Gas Energy filed petitions with the Missouri Public Service Commission to change their Infrastructure System Replacement Surcharge (“ISRS”) rate schedules to recover ISRS-eligible costs. On December 9, 2016, the Office of the Public Counsel (“OPC”) filed a motion requesting that the Commission deny the ISRS petitions or direct the parties to file a proposed procedural schedule leading to an evidentiary hearing. OPC alleges that certain costs in the petitions are ineligible under the law for ISRS recovery. The Commission will direct the parties to file a proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. The parties shall file a joint proposed procedural schedule no later than December 14, 2016. If the parties cannot agree on a single proposed schedule, they may file separate proposed procedural schedules by the same date.

2. This order shall be effective when issued.


