On September 28, 2018, Liberty Utilities ("Liberty") filed an application with the Missouri Public Service Commission pursuant to Commission Rule 4 CSR 240-2.060. Liberty requests approval of a PVC pipe replacement program and recovery of the associated costs through its Infrastructure System Replacement Surcharge ("ISRS"). Specifically the company is proposing that the Commission approve a ten-year PVC replacement program for approximately 64.5 miles of PVC pipe that remain in the company's Missouri distribution system. Liberty also requests that the Commission determine that the costs to implement the company's PVC replacement program be eligible for recovery through the company's ISRS mechanism if all other requirements for a proper ISRS filing are satisfied.

Liberty additionally requests a waiver of the 60 day notice requirement contained within Commission Rule 4 CSR 240-4.0017(1) due to the interested parties receiving notice through paragraph 17 of the Unanimous Stipulation and Agreement filed in GR-2018-0013.

may be interested, and a date will be set for intervention requests.
