ORDER DIRECTING NOTICE AND SETTING AN INTERVENTION DATE

On September 28, 2018, Liberty Utilities (“Liberty”) filed an application with the Missouri Public Service Commission pursuant to Commission Rule 4 CSR 240-2.060. Liberty requests approval of a PVC pipe replacement program and recovery of the associated costs through its Infrastructure System Replacement Surcharge (“ISRS”). Specifically the company is proposing that the Commission approve a ten-year PVC replacement program for approximately 64.5 miles of PVC pipe that remain in the company’s Missouri distribution system. Liberty also requests that the Commission determine that the costs to implement the company’s PVC replacement program be eligible for recovery through the company’s ISRS mechanism if all other requirements for a proper ISRS filing are satisfied.

Liberty additionally requests a waiver of the 60 day notice requirement contained within Commission Rule 4 CSR 240-4.0017(1) due to the interested parties receiving notice through paragraph 17 of the Unanimous Stipulation and Agreement filed in GR-2018-0013.

Notice of this application will be given to the general public and to others who may be interested, and a date will be set for intervention requests.

The Commission's Data Center shall mail a copy of this notice to the County Commission for each of the counties in Liberty's service area. In addition, the Data Center shall mail a copy of this notice to each party in GR-2018-0013, Liberty's last general rate case. The Commission's Public Policy & Outreach Department shall make notice of this order available to the media serving Liberty's service area and to the members of the General Assembly representing Liberty's service area.

IT IS ORDERED THAT:

1. The Data Center of the Missouri Public Service Commission shall serve notice as set out in the body of this order.
2. The Public Policy & Outreach Department of the Missouri Public Service Commission shall serve notice as set out in the body of this order.
3. Any person wishing to intervene in this matter shall file an application to do so no later than October 31, 2018. Such application shall be filed with:
