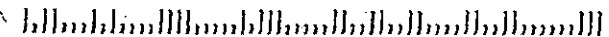

MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned attorney, and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of service authority of Asia Talk Telecom, Inc., d/b/a HelloCom Inc., (HelloCom or Company) and states as follows:

1. On November 20, 2005, the Commission granted HelloCom a certificate of service authority to provide competitive intrastate interexchange telecommunications services in Missouri in Case No. XA-2006-0153.

2. On April 26, 2006, the Missouri Secretary of State's Office (SOS) administratively dissolved the parent company, Asia Talk Telecom, Inc., for failure to file a correct and current annual report. According to §351.476.1, a corporation administratively dissolved may not carry on any business except that necessary to wind up and liquidate its business and affairs. See Attachment A.

3. On September 30, 2010, HelloCom's fictitious name registration expired due to the Company's failure to renew its registration with the SOS. See Attachment B.

4. According to §417.200, "...it shall be unlawful for any person to engage in or transact any business in this state under a fictitious name without first registering same with the secretary of state as herein required."

5. Additionally, HelloCom has failed to file its calendar year 2010 annual report with the Commission. On May 24, 2011, the U.S. Postal Service returned a letter sent by the Staff concerning the Company's delinquency in filing its annual report. The returned letter is marked as "Return to Sender – Not Deliverable as Addressed – Unable to Forward."

6. On June 2, 2011, the Staff contacted HelloCom's previous counsel, Mr. Lance Steinhart. Mr. Steinhart conveyed to the Staff that HelloCom is no longer in business.

7. Because of the Staff's good faith belief that the Company is no longer operating in Missouri and that the Company can no longer lawfully provide telecommunications services in Missouri, the Staff recommends that the Commission cancel the Company's certificate.

8. The Commission has the authority to cancel a telecommunications certificate pursuant to §392.410.5 RSMo (Supp. 2010), which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

9. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W. 2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends that the Commission cancel the tariff and certificate of service authority of Asia Talk Telecom, Inc., d/b/a HelloCom Inc., to provide competitive intrastate interexchange telecommunications services in Missouri.
